#### **REGISTRATION FEE**

#### **REGISTRATION AND CONDITIONS OF PARTICIPATION**

Registrations are now open and will remain so until the May 31, 2024. The decision as to which papers will be accepted for presentation will be taken by the Members of the Scientific Committee, following the consultation with the Organising Committee. Participants will cover their own travel, accommodation and incidental costs (e.g. visa fees) related to their trip to Varna, Bulgaria. **This is a self-funded event and the organisers are unable to cover any travel or accommodation costs**.

## HOW TO SUBMIT A CONFERENCE PAPER (SHORT PAPER) AND DETAILS ABOUT THE PUBLICATION

A conference paper (short paper) in English language should be written up to 3000 words. Papers will be reviewed by the Scientific Committee of the conference.

All accepted conference papers (short paper) will be published in the Proceedings of the conference, with ISBN number, only if the conference fee is paid in time. This volume will include short version of your papers. The full contact details of the author(s) need to be provided. Abstract (max. 150 words) should be written in the third person and not in the first or second one (e.g. I, me, or my paper). Short papers should explain the purpose of the paper, the approach taken, the methods of analysis (in empirical papers), main findings, the principal results and major conclusions. This file should be submitted as a .doc file. The template you will find on the conference site <a href="http://issd.rau.ro/">http://issd.rau.ro/</a>

We strongly encourage all participants to prepare their papers in the template. The papers that do not meet the conference formatting criteria will not be included in the Proceedings of the conference.

All long papers will be reviewed for the publication in journals following their normal review criteria. The acceptance of a paper for the conference is not a guarantee of publication in the journals.
