### Call for Papers TIMTED 2025

The conference aims to bring together academics, researchers, PhD students, and professionals worldwide. The conference reviewers will evaluate these first. Every participant may submit a maximum of two extended abstracts as sole author or co-author. Only original papers on subjects related to all fields of economics and business administration are accepted.

## CONFERENCE FEE

The conference fee is 150 Euros per participant, and it includes attendance, conference bag and materials, coffee breaks and participation in the Gala Dinner. Ph.D. Students pay a reduced conference fee of 75 Euros per participant.

## IMPORTANT NOTES

All accepted extended abstracts will be published in a conference volume with an ISSN. Authors can further submit full papers to be considered for publication in one of the

journals associated with TIMTED 2025. The author(s) must comply with the respective journal's requirements. Updated information on publishing opportunities will be available on the TIMTED 2025 conference website.

The three-day conference program will include a plenary session and several special and parallel sessions. The official language of the conference is English.
