This scientific event is the **12th conference traditionally organized by the Faculty of Economics** from Targoviste. But the name has evolved in line with the new challenges faced by the Romanian economy and the international context. Thus, the first six editions (1994 – 2004) were focused on the theme of post-communist changes and efforts to join the EU and were entitled “Management of transition”. The next two editions, under the name “European Spaces” (2012, 2014), were dedicated to the implications of Romania’s integration into the EU and the EU expansion. The current topic was chosen starting with 2016 and has led to the organization of three other conferences so far (2016, 2018 and 2021).
